**RATIONALE:** The point of the Judicial Committee is to resolve our disputes on our own, lessening the need for Libertarian National Committee or Board intervention. As it is right now, the only appealable items are Board items that have underwent an actual vote meaning that the Board can avoid member review simply by not voting. That undermines the a good portion of the purpose of a Judicial Committee.
