1.	In order to make life more affordable in Colorado, I will vote against tax increases and vote for substantial and permanent reductions in taxes.	
2.	I will stand up for excellence in learning by promoting school choice and the freedom of families to make their own educational decisions, including making public spaces available for home schools, charter schools and alternative schooling programs.	
3.	I will fully defend the Taxpayer Bill of Rights (TABOR) and do everything in my power to protect it and restore TABOR protections.	
4.	In order to make housing more affordable, I will vote to lower mill levy rates, and support any effort to lower property taxes.	
5.	I will support an audit of my City/County/District and its use of tax money for fraud, waste and abuse (including a forensic audit if needed).	
6.	I will fully defend the Colorado Open Records Act (CORA) and do everything in my power to protect it, and do everything possible to ensure that my jurisdiction is adhering to the spirit of Colorado's Sunshine Laws.	
7.	I will support holding criminals who commit violence & theft accountable, & also recognize that victimless crimes aren't actual crimes.	
8.	In order to support Colorado Agriculture & Ranchers, I will support food freedom, such as local meat processing, raw milk, cottage food producers and support backyard livestock rights.	
9.	I will vote against any new restrictions on our Right to Keep and Bear Arms and repeal existing restrictions.	

10.	I will defend the right of direct ballot access by citizen initiative and if needed enact changes to allow citizen initiatives in my jurisdiction.	
11.	I will defend medical freedom by opposing any mandatory vaccine requirements for employment and opposing state medical mandates.	
12.	I will support replacing Civil Asset Forfeiture policies with a Criminal Asset Forfeiture policy to ensure that only individuals convicted of a crime should have their property confiscated.	
13.	I will vote to ban red light cameras, speed cameras and other unwarranted surveillance devices (such as Flock Cameras).	
14.	I will support the ability of peaceful people to live their lives freely without government interference.	
15.	I will support and uphold the rights of individuals afforded in the Colorado and US Constitutions.	
16.	I will support removing and replacing local officials (including town manager) if they fail to uphold their oath of office or adhere to Constitutional Principles.	
17.	I will support revisiting the charter to return the power to elected representatives and limiting the power of unaccountable bureaucrats.	
18.	I will oppose any attempt to create a municipal trash monopoly, and will attempt to repeal any requirements already in place.	
19.	I will support Home Rule Status for my community and oppose attempts by the State to create top-down policies.
