# **Board Reports**

## Legislative Director

#### Overview:

This month, my focus has been on strengthening our relationships with liberty-minded legislators and advancing policy goals that align with core libertarian principles. Building and maintaining these connections is critical for ensuring that our ideas have a voice within the state legislature and that the Libertarian Party of Colorado is viewed as a credible, values-driven participant in policy discussions.

#### **Civil Asset Forfeiture Reform:**

I've been collaborating with **Representative Ken DeGraaf (R–CO)** on efforts to promote a **Civil Asset Forfeiture Reform Bill** for the upcoming legislative session. This bill aims to strengthen due process protections for Coloradans by limiting the ability of law enforcement agencies to seize property without a criminal conviction.

This issue represents a clear and tangible defense of individual rights and private property—core tenets of our platform. By engaging early in the legislative process, we can help ensure that the final version of the bill reflects strong libertarian principles and reduces government overreach.

### **Building Alliances with Liberty-Focused Legislators:**

Our ongoing engagement with legislators like Rep. DeGraaf is part of a broader strategy to develop relationships with lawmakers who are sympathetic to libertarian values, even if they are not formally part of our party. These relationships create opportunities to:

- Advance libertarian policy priorities through bipartisan or cross-partisan collaboration.
- Increase our credibility as a principled voice in legislative discussions.
- **Build trust** that can open doors for future cooperation on issues such as taxation, government transparency, and personal freedom.

By maintaining a professional and cooperative presence at the Capitol, we position the Libertarian Party of Colorado as a consistent advocate for liberty, rather than a distant critic of the political process.

### **Next Steps:**

- Continue working with Rep. DeGraaf and other allies to finalize and promote the Civil Asset Forfeiture Reform Bill.
- Identify additional legislative opportunities for partnership on issues like school choice, occupational licensing reform, and privacy rights.
- Explore ways for LPCO members to engage in public testimony or grassroots advocacy to support these legislative efforts.

### Closing:

Our long-term success depends not only on running candidates but also on **showing results for liberty** through meaningful legislative influence. By building strong, trust-based relationships with like-minded legislators, we can help ensure that libertarian principles are represented where laws are written.

# Campaigns Director

2026 candidates as of this writing are James Wiley for Secretary of State (I have not yet spoken with Mr Wiley to determine if he has officially declared, or if he is still considered 'exploratory'). No other known candidates as of the writing of this report.

Per my Campaigns Director campaign material, I plan to develop the Campaigns Department by 'Divisions'. Those Divisions are: 1) State and Statewide Partisan Campaigns 2) County Campaigns 3) Municipal Campaigns 4) Vacant Offices, 5) Elected/Appointed Officeholder Support

The aforementioned is my primary focus. I am seeking division directors for each division, as well as volunteers reporting to each. I have just begun these efforts, and so there is not much yet to report. I have appointed Norm Olsen to the role of Division Director of Vacant Offices. I am in current discussions with a longtime Libertarian for forensic research under Mr Olsen in that division, as well as one other volunteer to work on that team. Additionally I have another LPCO member interested in working in the State/Statewide Partisan Division. I will reveal the names of these potential volunteers once they have been appointed to their roles within their respective divisions/teams.

No active candidate recruitment has yet taken place.

There are currently no candidates seeking 'statewide' office (Governor/Lt Governor, etc..) other than Mr Wiley for SOS.

I believe that it is important for me to manage the expectations of this board and the membership of the LPCO at large. I <u>WILL NOT</u> be actively recruiting for a "full slate" of candidates for the election year 2026. As mentioned in my campaign for this directorship, I believe that I/we MUST take a long-term approach to building this party. As such, it is imperative that I build a strong team, headed by the aforementioned Division Directors to achieve this goal. My legacy in this role will be a 'turn-key' Department that any motivated Director can step into and run. It is here that I shall be focusing my efforts. This should not be construed to mean that I will not be working with any and all candidates who announce their intention to seek the LPCO nomination. Quite the contrary, supporting these candidates WILL be a priority. I do however feel that my efforts must be spent building 'the machine' that can insure future success. These efforts will take years, not weeks or months.

I mention the above because I have received many phone calls, texts and emails from people who are anxious to see miracles, and I cannot deliver miracles. I will however work to build a Campaigns Department of which every member of the LPCO can be proud, and whom non-libertarians can feel confident will run candidates for whom they can be comfortable voting.
